As a member of SV Tennenlohe e.V. 1950, you benefit from the various sports offers available to you depending on your membership. At the same time, you have assumed membership obligations, which include the fixed membership fee. As part of this membership, we are obliged under the EU Data Protection Regulation EU-DSGVO (VO 2016/679) and the new regulations of the Federal Data Protection Act (BDSG) to inform you of the purpose for which your personal data is collected, stored or forwarded by us. Data processing:

In order for us to be able to carry out our association work to fulfil and promote the statutory purpose of the association, we process a large amount of personal information from you. The data is collected largely in order to ensure the work of the association, to establish and manage memberships, to levy and collect membership fees, to provide you with information about the association and its events and to fulfil the obligations incumbent on the association - also towards third parties.

For this purpose, we process your personal data, in particular gender, first name, surname, address (street, house number, postcode, town), date of birth, date of joining the club, department and, if applicable, team membership, bank details, if applicable the names and contact details of the legal representatives, telephone numbers and e-mail addresses, if applicable function in the club, if applicable household and family membership in the case of allocation to the family contribution.

Of course, your data will always be treated strictly confidentially.

Data recipient:

We only transfer your personal data to third parties if this is permitted by law, your membership requires this for other reasons or you have consented to this.

Recipients of your personal data may include, in particular, higher-level associations, insurance companies, other association members, cloud services and others.

As a member of the Bavarian State Sports Association, Georg-Brauchle-Ring 93, 80992 Munich, the club is obliged to report the following data of its members to the BLSV as part of the inventory report: Surname, first name, date of birth, gender, sporting affiliation. The report is for administrative and organisational purposes of the BLSV. Insofar as the practice of certain sports in the club results in an allocation to sports associations, the necessary data of the club members concerned shall be made available to these associations for their administrative and organisational purposes or for the implementation of competition activities.

In the context of public relations work on association activities, personal data is published in notices, in the association's newspaper and on websites and passed on to the press. This includes, in particular, data from generally accessible sources: Participants in sporting events, team line-ups, results, goal scorers, age or year of birth. The publication of photos and videos taken outside of public events will only be made on the basis of the consent of the persons depicted. The data of the members of the executive committee, the heads of the departments and the exercise instructors and supervisors with first name, surname, function, e-mail address and telephone number are published on the website of the association.



Member data will also be forwarded to the Executive Committee for the purpose of congratulating members on their birthdays and honouring members who have been members of the Association for 25, 40 and 50 years. If you do not agree to this, you can object at any time.

However, the transmission is always for the purpose of carrying out the work of the association.

Data storage:

We keep your personal data for as long as is necessary for the performance of the service and the duration of your membership. Otherwise they will be deleted. In the event of termination of membership, personal data, insofar as it relates to cash transactions, will be stored for up to 10 years from the effective date of termination in accordance with the provisions of tax law. However, due to legal requirements, longer retention periods may apply.

Your rights:

You have the right to obtain information about the personal data concerning you (Art.15 DS-GVO). You can also request the correction of incorrect data (Art. 16 of the GDPR). In addition, under certain conditions, you have the right to have data deleted (Art. 17 DS-GVO), the right to restrict data processing (Art. 18 DSGVO) and the right to data portability.

The processing of your data is based on legal regulations (Art. 6 para. 1 lit. a), b), f); DS-GVO. Only in exceptional cases do we require your consent. In these cases, you have the right to revoke your consent for future processing at any time.

Pursuant to Art. 21 DS-GVO, you have the right to object to data processing if it has been carried out in accordance with Art. 6 (1) e) or f).

You also have the right to complain to the competent supervisory authority if you consider that the processing of your personal data is not lawful (Art. 77 DS-GVO).
